We are passionate about equipping young people with vocational skills.

Uganda has not only the youngest population in the world, but also the highest unemployment among 15 – 25 year olds (83%).

KFTC is a unique project delivering relevant skills in a creative 22-acre facility for 17 – 25 years olds over a one-year training course.

The majority of our students come from the north of Uganda where LRA rebel activities have been at their worst and many have been orphaned due to AIDS.

It cost around £23 per week to train a young person at Kira, our aim is to find 800 people donating just £1 (plus giftaid) a week to enable Kira Farm Training Centre to keep training 40 young people each year.
